



Your Pay-Direct Drug Card

The Pay-Direct Drug Card is a great feature that is included in your benefit plan. With the drug card, you no longer have to complete a claim form or wait for reimbursement for prescription drugs.

Your Drug Plan

The benefit plan covers prescription drugs up to \$10,000 per person, per calendar year for you and your eligible dependents. Most prescription drugs are eligible, provided they:

- Require a prescription by law
- Have been assigned a drug identification number (DIN)
- Are dispensed by a licensed pharmacy
- Over the counter drugs are not a benefit

** Your plan Excludes all drugs covered by Non-Insured Health Benefits (NIHB) (Status employees or Status dependents), therefore pay direct does not work for those prescriptions as NIHB will cover the cost.

Using your Drug Card

- Always carry your drug card with you and present it to the pharmacist when you drop off your prescription. If your pharmacist does not accept drug cards then, you will need to pay for the prescription yourself and then submit a paper claim with your original receipt or submit online.
- Pay direct drug card works in <u>Saskatchewan</u> only.
- Pay direct drug card can not be used for any top up on drugs over and above NIHB coverage you will need to pay and then submit the receipts to FNISLP or by using the Blue Cross App .
- Pay direct drug card can not be used for compound drug prescriptions you will need to pay and then submit the receipts to FNISLP or by using the Blue Cross App.

If your spouse has a benefit plan with a drug card

- To fill prescriptions, you and your spouse must use your respective plans first.
- If you and your spouse both have dependent coverage, submit claims for dependent children to the plan of the parent whose birthday falls first in the year.
- If your spouse also has a benefit plan that includes a drug card, your pharmacy may be able to send claims to both plans at the same time. Confirm with your pharmacy if this option is available to you.

Protecting your privacy

If you leave your job

If you leave your current employer, you will no longer be eligible for coverage.
